INNOVATION IN ACTION

UNITED IS THE WAY TO BELONGING

In this time of uncertainty, I find myself reassured knowing that the work of Greater Twin Cities United Way does not stop. We continue to unite changemakers to create a community where all people thrive. I am especially grateful for opportunities that allow us to gather and learn from one another, advocate for social good and lift the amazing work being done by our partners to support our neighbors.

One powerful way we bring people together is through our advocacy work. Already this year, our advocacy team has been busy engaging with community members, nonprofit partners and policymakers to drive meaningful change.

In February, we partnered with the Start Early Funders Coalition to gather local children, parents and guardians, early childhood educators and other advocates for Advocacy for Children Day at the Minnesota Capitol. With more than 200 attendees and

a family- and children-focused program, the event was an opportunity to ask legislators to prioritize Minnesota's youngest community members by investing in early childhood education, trauma-informed care and more.

Additionally, at a time when state lawmakers are considering a steep funding cut for the Early Learning Scholarship program, we are advocating for bipartisan legislation to maintain scholarship funding at its current levels to ensure quality child care for more Minnesota families.

Housing continues to be the most common reason people call our 211 resource helpline — amounting to 45% of all 211 requests. We know that without stable housing job training programs, child development efforts and workforce initiatives are less effective, which is why housing is one of our lead advocacy issues this year.

In March, Greater Twin Cities United Way staff and supporters gathered at the Capitol for Minnesota Homeless Day on the Hill to advocate for better housing policies that increase access to safe, affordable housing.

That same week, during Hunger Day on the Hill, we advocated for policies that ensure all Minnesotans have access to the food they need.

TOCQUEVILLE SOCIETY SUPPORT COMES FULL CIRCLE

New Tocqueville Society members Mike and Wendy Wethington bring their support of Greater Twin Cities United Way full circle with a gift honoring the philanthropic leadership of friends and founding members, Jeff and Terri Greiner.

Mike and Wendy were college sweethearts who have called the Twin Cities home for nearly 50 years. After raising their two children and building several successful businesses here, the couple has a simple philanthropic philosophy of giving back to the community that has given them so much.

"My hope for the future of the Twin Cities is that we can find economical and sustainable ways to provide affordable housing and a stable food supply for everyone," said Wendy. "Because without those two things, other programs can't work as well."

Inspired by the philanthropy of respected peers and colleagues that support United Way, the couple appreciates the value the organization brings to the people of the Greater Twin Cities.

"It's important to us that United Way has the ability to impact everyone in a community," said Mike. "What's interesting strategically is looking at our current environment and thinking about how we can leverage the assets we have in an

even more meaningful way. And that's cool."

A self-described serial entrepreneur, Mike has built and grown several successful businesses throughout his career. It's through these ventures that Mike connected with people he describes as legends within the community – incredible humans who ultimately inspired the couple's support of Greater Twin Cities United Way.

One such influence was Mike's first business partner, Bart Greenwood, who was a passionate supporter of United Way and served as an executive-on-loan with the organization before his passing in 2009. Bart found the experience deeply meaningful and would often express its profound impact. For this reason, Mike and Wendy gave their first gift to United Way in honor of Bart's memory.

"Bart was a brilliant guy who believed the work of United Way, in part because the organization was so efficient," said Mike. "That is something that is attractive to me as well."

Later, Mike got to know Jeff Greiner when he became an investor and board member for his second business venture, Outsell. Over the years, Jeff guickly became a trusted business partner and friend.

"leff is such an incredible human being and is truly a giver," said Mike. "We were pleased to be a part of recognizing he and Terri for their generosity through the Tocqueville Society."

leff and his wife Terri were among the small group of donors who founded the local Tocqueville Society and last year they received the Lifetime Legacy Award honoring their generosity and engagement through the years. Personal connections like these play an important role in influencing which nonprofits the couple chooses to support. But understanding an organization's strengths and ability to make an impact is equally important.

"One of United Way's great strategic advantages is the leverage model that provides the ability and infrastructure to work with a lot of organizations and vet the best of the best nonprofits to help people," said Mike. "It's just a beautiful model."

BOB BUUCK

Lifelong Visionary Remembered for Quiet Philanthropic Leadership

The Tocqueville Society remembers with gratitude entrepreneur and philanthropist, Bob Buuck. The son of Lutheran missionaries and the visionary co-founder of American Medical Systems (AMS), Bob exemplified a steadfast devotion to his family, friends, colleagues and community throughout his life.

He and his wife, Gail, raised three children in the Twin Cities while he was building one of Minnesota's most successful medical device companies. Together, they shared a passion for this community and quietly supported many local philanthropic endeavors over the years.

Their support of Greater Twin Cities United Way goes back decades, beginning with workplace giving campaigns at AMS, annual giving, early support of Screen at Three, and the establishment of the Buuck Family Early Childhood Education Endowment. Their most recent gift of \$30 million to United Way will be transformational for our community. This incredible act of generosity will accelerate the impact of our work serving children and families for years to come by supporting our nonprofit partners and our new innovative solutions working to address barriers to success in the areas of early childhood education, housing, food security and jobs.

Bob passed away on January 4 after a valiant battle with Alzheimer's Disease. Though we'll miss his wit and wisdom, his tremendous legacy of compassion endures. We extend our deepest sympathy to his beloved wife, Gail, and their family and friends.

Remembering 100 Years of Kindness and Generosity

The Tocqueville Society and Tocqueville Legacy Circle mourn the loss of centenarian, philanthropist and friend, Dorothy Kirk. A fiercely independent woman who cared deeply for our community, Dorothy believed in doing good work for people.

She was a lifelong Minnesotan and a devoted Vikings fan who watched every game.

She attended the University of Minnesota for two years before moving to California to complete her degree and begin her career as a teacher for the deaf – ultimately, returning home to follow in her mother's footsteps by teaching at the Minnesota School for the Deaf.

She also worked at Dayton's department store as an assistant buyer in the children's department.

An avid volunteer who took great pleasure in being able to help others, Dorothy helped transport patients at Fairview Southdale Hospital for nearly 40 years and was a frequent volunteer with the Minnesota Orchestra and the Guthrie Theater. Recently, she enjoyed selling bingo cards every Friday evening at her home, 7500 York Place.

When asked why she gave to organizations like Greater Twin Cities United Way, Dorothy shared that so many people are hurting, and she wanted to help. She was pleased that as a single woman, she was able to invest wisely and give back to her community. She also enjoyed attending many charity events, like the Legacy Society Appreciation Luncheon and Tocqueville Society Annual Dinner each year and getting to know other donors.

Dorothy passed away peacefully on March 25, one day short of her 100th birthday. Her kindness, generosity and friendship touched countless lives, and she will be greatly missed. We extend our sympathy to her cherished nieces, nephews and cousins, as well as the many friends she leaves behind.
